- 14.1 If the Bidder fails to deliver or to perform the Services within the period(s) specified in the Contract, the Purchaser should without prejudice to its other remedies under the Contract, deduct from the Contract Price, as liquidated damages. The deduction will be a sum equivalent to the percentage specified of the delivered price of the delayed or unperformed services for each week or part thereof of delay until actual delivery or performance, up to a maximum deduction of the percentage specified if any. Once the maximum is reached, the Purchaser may consider termination of the Contract.
- 14.2 Penalty: At the rate of 0.5% per week as per the various terms and conditions of this contract subject to a maximum of 10% of the total contract value, for delay beyond the agreed period.

15. TERMINATION BY DEFAULT

- 15.1 The Purchaser may, without prejudice to any other remedy for breach of contract, by written notice of default sent to the Bidder, terminate the Contract in whole or part;
- (a) if the Bidders fails to deliver within the time period(s) specified in the Contract, or within any extension thereof granted by the Purchaser, or
- (b) If the Bidder fails to perform any other obligation(s) under the contract.
- 15.2 In the event the Purchaser terminates the Contract in whole or in part, the Purchaser may engage, upon such terms and in such manner as it deems appropriate, Services similar to those undelivered, and the Bidder shall be liable to the Purchaser for any excess costs for such service. However, the Supplier shall continue the performance of the Contract to the extent not terminated.

16 FORCE MAJEURE

- 16.1 For purposes of this Clause "Force Majeure" means an event beyond the control of the Bidder and not involving the Bidder's fault or negligence and not foreseeable. Such events may include, but are not limited to, acts of the Purchaser either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 16.2 If a Force Majeure situation arises, the Bidder shall promptly notify the Purchaser in writing of such conditions and the cause thereof. Unless otherwise directed by the Purchaser in writing, the Supplier shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

17. TERMINATION FOR INSOLVENCY

The Purchaser reserves the right to terminate the Contract any time by

18. RESOLUTION OF DISPUTES

- 18.1 The Purchaser and the Bidder shall make every effort to resolve amicably by direct informal negotiation any disagreement or dispute arising between them under or in connection with the Contract.
- 18.2 If, after thirty (30) days from the commencement of such informal negotiations, the Purchaser and the Bidder have been unable to resolve amicably a Contract dispute, either party may require that the dispute be referred for resolution to the formal mechanisms. These mechanisms may include, but or not limited to, conciliation mediated by a third Party, adjudication in an agreed national forum, and national arbitration.
- 18.3 The jurisdiction of any disputes, suits and proceeding arising out of the tender shall be in appropriate court in Pernem Goa.
- 19. The rate quoted should be on Kg basis as per **Annexure-V** to the destination stations inclusive of booking, collection, loading/unloading, transportation, handling, door delivery and statutory charges/taxes out bound delivery etc.
